

Getting Started – Changing Your Political Status

Revised January 2026

What You Will Need:

- 1. Passport Photos:** (Walgreens, CVS, Post Office) Must be Passport Quality. Don't accept a poor quality photo. Have them put it on a flash drive along with the physical photos. These go on your Witness Testimonies and also download to the LRO for your Credential Card. You will usually get four (4) 2" x 2" photos. You don't need the flash drive, but it comes in handy. It's just an extra cost. Do not take a photo with your camera. They must be passport quality and there are standards to be met.
- 2. Certified Copy of Your Birth Certificate:** Must have the raised embossed seal and on bond paper, from the State or Country you were born in. Obtain from your born state Vital Statics Office. You will need to bring it with you when you record your paperwork, as our recording secretary will need to scan it for our records. Do not crease, as it makes it hard to scan.
- 3. Blue, Red and Gold Ink Pens:** You will never autograph in Black Ink. These will be used whenever you "autograph" your "By: Line©" when signing your American State National Name.
- 4. Red Ink Fingerprint Pad:** Must be "red" ink. Used to seal stamp your autograph on documents. Only the De Facto Government uses black ink.
- 5. Documents:** You may only do the "1779 One Page Document" with the two (2) Witness Testimonies which will change your Political Status to "American State National" or... do the complete 928 Document Package and the Notice Letters that give you complete protection. You may need to complete our Questionnaire prior to doing your paperwork, and some questions may require research.
- 6. The "1779 One Page Document":** "Declaration of the Naturalization Act of 1779". Make sure you use the correct form for your status. Wait to sign them until you are in front of a Notary Public (Bank, CU, UPS Store, Etc.) or our State Recording Secretary. Note: A State of State Notary only witnesses your signature. They do not know what color of ink you should be signing in or what style to use. Proper Signing of your documents is critical. Our Paperwork service to compose your Two (2) Witness Testimonies and your 1779 Document is \$10 and you will know your paperwork has been created, signed and sealed correctly. IF mistakes are made, they can be corrected at the signing, saving everyone's time and you money.
- 7. Two (2) Witness Testimonies Statements:** Witnesses *must* be someone who has known you for at least seven (7) years. Can be a family member, friend, co-worker, Spouse, Children (over 21), Etc. You will need two (2), one copy from two witnesses' testimony. Note that the originals will have one of your Passport Photos attached to them, in the proper spot, before it gets witnessed by a notary.

8. Land Recording Office (LRO): <https://members.americanstatenationals.us> You will need to set up your Personal LRO Account, before you can have your documents/notice letters recorded and published on the LRO. You will need to download your Passport Photo and a good quality right thumbprint on to your account. Apply your inked thumbprint on to an 8 ½" x 11" piece of paper until you get a good quality print (not smudged) and download that single print on to your account. Although you may change your photo from time to time; your thumbprint cannot be ever changed for security reasons. Only an LRO Official can go in and change things. Please note that the LRO has upped their standards and it is best just to open your account and let our Recording Secretary download your Photo, Thumbprint and autograph to the LRO. When you come to record your paperwork/notices, our Recording Secretary will get your thumbprint and signature on an LRO form. We must make sure the thumbprint is not smudged, and your signature is correct. The LRO has certain guidelines they have recently adopted. They reject photos and thumbprints all the time.

9. 928 Document Package: You may create your 928 Document from the website at: tasa.americanstatenationals.us/ but we don't advise it. These are fill-in information documents and are free. You may also use the LRO Document Generator at members.americanstatenationals.us. But there is a cost of \$52 to generate all your 928 Document. We suggest you use OUR Paperwork/Notices Service. As we are able to know which documents/notices you require and can easily make any corrections, if necessary. Our fee for composing all your required 928 documents/notices is \$30.00, plus an extra \$5.00 per documents if you require an extra Power of Attorney (POA) or extra Acts of Expatriation (AOE) documents. Filling out your Questionnaire will help us determine which documents you will need. You are responsible for your documents. It is difficult to understand all that is required on how these documents and notices are composed. We have worked long and hard on putting together our paperwork through much trial and error. Wording and margin are critical.

10. Here is a list of all the 928 Documents: Note that not everyone will need to do certain documents. It is a matter of what your life's history may be. Some people will have more & some less. What you have done throughout your life is the determining factor.

> Deed of Re-Conveyance: Note that there are two (2) - One if you were born in America and One if you were not born in America. Make sure you choose the correct one for your status.

> Certificate of Assumed Name

> Act of Expatriation: (JOHN HENRY DOE)

Note: You would need a set for each name you ever used. i.e.. If married, you would need your married name (3x) and your born name (3x) This would also include court name changes, pen names, divorces, nicknames. Any name that you would have received mail.

- > Cancel Power of Attorney
- > Foreign Sovereign Immunities Act (FSIA)
- > Paramount of Life Claim:
- > Marriage Paperwork: (if needed)
- > Baby Deed (if needed)
- > Military Letter: (Veterans Only) Sent to your branch of service, with your DD214.
- > Recording Cover Sheet of Document you are recording & publishing
- > Diagram of Fraud: Personalize with your names inserted into boxes.
- > Fee Schedule: This seems to get updated about every year as they keep adding offenses.
- > Common Carry: Lets you conceal carry without a permit.

11. **Notice Letters:** Federal Notice Letter for Federal Offices are on the tasa. website. Each State Assembly, determines what we require for our individual State Assembly. Both the Federal and State Notice Letters required by the Nebraska Assembly are part of our Paperwork Service Package. Your documents will be on Public Record, but sending Notices to State of State entities makes them aware of your political status change and is your responsibility.

Here is a List of the Notices Letters you will need to mail out...

- > **Declaration of Political Status Document with Cover Letter: Two (2) Different Letters:** One notice goes to the Nebraska Secretary of State (this one was revised and you need to use the one that has the six (6) points in the body of the notice, and the other one goes to Assistant Secretary of State, Bureau of Consular Affairs in Washington, D.C. It is a lot longer letter and directs her to notify Nebraska State Officials and Offices. The Consular Affairs Letter requires some homework, as you will need to search the web for the officials within the county you live in. Everybody is different, depending on your county. Researching those officials is part of our paperwork service. Each county has different officials to notify.
- > **Revocation of Election to Pay Taxes:** There are two (2) Notice Letters. One goes to the IRS in

New York and the other goes to the IRS in Washington D.C.

- > **Voter Revocation Letter(s):** One to your State Voter Registration and One to your County Voter Registration. Check the Nebraska Voter Look-Up website to make sure they took you off the list. If you never voted in Nebraska, you could just check the website to make sure you aren't registered print out a copy for your and our files.

- > **State Notice Letters:** Each letter says the same thing, but are addressed to each of the following State Officials: Nebraska Attorney General, Nebraska District Attorney, Your County District Court, and the Nebraska Secretary of State.

Note that all notice letters must be mailed out and you need the green card return receipts back signed and dated. Copies of these receipts need to be on file with the Assembly, so we have proof that you completed the paperwork process and are a member in "Good Standing".

The postage to send these Notice Letters is approximately \$27 each, and you have nine (9) initial notice letters that will require at least \$243 in real stamps. You may send these out a little at a time, if it is a money issue. You are waiting for the return green receipt as proof of delivery for your files, that show that they received them. Some may take a month before you get your return receipt back. The IRS will probably send you a letter every 1 to 3 months asking for more time to review your case. These are usually form letters. Do not respond. Prior IRS issues, before you changed your status may still be an issue, as you "volunteered" with your signature on the IRS form. Changing your political status is not a get out of jail free card.

12. Once you get your original paperwork back you can order your Credential Card from the LRO (\$50 for two (2) cards, (this may take from two (2) weeks to a month to receive them). Then you may open an account with the GFG Bank Prosperity Union (Global Family Group) by creating an account and uploading certain documents and information to be vetted by them. This may take weeks or months according to how busy they are, as they are staffed by volunteers only and are serving the whole world.

13. This is your initial procedure for changing your Political Status. There will be additional paperwork as procedures change and so does your situations. Educating Yourself is Critical. There is much information available & joining your State Assembly is critical in order for us to stand up of our Four Pillars.
